This cause came before the Court on Plaintiffs' Motion to Take Possession, Custody and Control of all Bluewater Assets, Accounts and Property Based on Abandonment; and Defendants timely filed a response. Kevin Liske and Larry Hancock have resigned from the Board of Managers of Bluewater Toxicology, LLC. The sole remaining member of the Board of Managers has all the rights and responsibilities to run that business in accordance with the Operating Agreement, including control of the operations and assets. IT IS HEREBY AGREED, ORDERED AND ADJUDGED that the Plaintiffs' Motion is SUSTAINED, and that each of the Defendants are hereby divested of all rights in Bluewater Toxicology, LLC operations or assets, including but not limited to, the Mt. Washington,

Kentucky lab and real property, assets, accounts (customer accounts and also any and all bank accounts in the name of Bluewater Toxicology, LLC), records, documents, intellectual property, names, and tangible items and any item identified in the Purchase Transaction documents ("Property"), subject to pending adjudication on the merits of this case and the final resolution thereof. The sole remaining member of the Board of Managers of Bluewater Toxicology, LLC shall maintain dominion and control over the Property and operations of Bluewater Toxicology, LLC consistent with the rights and responsibilities set forth in the First Amended and Restated Operating Agreement of Bluewater Toxicology, LLC executed on or about September 5, 2017.

Defendants are directed and ordered to return to the Bluewater lab location during normal business hours all Property within three (3) business days, including all keys and any means of access. Defendants are further prohibited from accessing any Bluewater Property through any means, including electronic and/or by surveillance. Any Bluewater item or property or communication that comes in the possession, custody or control of any Defendant is to be immediately delivered to Jennifer Bolus at the Bluewater lab.

Plaintiff, Solar Holdings Group, LLC, consistent with the Purchase Transaction documents and security agreements and as secured party, is hereby delivered all rights to possession, custody, and control of Bluewater and its Property, including rights of access and quiet enjoyment of the real property subject to pending adjudication on the merits of this case and the final resolution thereof.
